ENZACTA Autoship Program Terms and Conditions

The ENZACTA USA, LLC (ENZACTA) Autoship Program is an elective agreement for Independent Business Owners (IBOs) and Personal Customers to participate in and allows a continuing monthly order to be debited from a credit/debit card. By signing this agreement, IBOs and Personal Customers desiring to participate in the Autoship Program agree to the following terms and conditions:

- Order:** I will specify the quantity of products which I desire to receive every month on the Autoship Order Form which is part of this agreement.
- Method of Payment:** I will supply ENZACTA with valid VISA, MASTERCARD, AMEX, or DISCOVER number(s), expiration date(s), and security code(s) in the space provided on the order form. All purchases made by me pursuant to the Autoship Program shall be paid by credit or debit card. The method(s) of payment I have selected will not be changed without my prior written notification. I authorize ENZACTA to establish an automatic credit card debit arrangement as specified in the order form to pay for each monthly automatic delivery order. Each month the card listed will be debited the day as stated on the first page of this form and shipped the following day. If this day falls on a Saturday, Sunday or a holiday I understand my card will be charged on that day and the shipment will occur on the following business day. ENZACTA will make no other charges to my credit card account except those I have authorized. (Sales tax charges may fluctuate in accordance with changes in applicable sales tax rates).
- Shipping:** I understand that ENZACTA ships orders daily (Monday - Friday). If the debit or charge date falls on a Saturday, Sunday or a holiday, ENZACTA will ship my order on the following business day from my requested monthly charge date. I understand and agree that the products selected on the order form will be sent to the address listed each and every month as I have indicated unless I notify ENZACTA in writing of changes I wish to make. ENZACTA will make the adjustments specified in my written notification no later than five (5) business days after receiving such notice.

I understand that ENZACTA is not responsible for orders once they have been shipped. If a package is lost or stolen during transit the IBO should contact the Orders Department at ENZACTA to discuss possible options.

- Availability of Product:** I understand that the specific products which I have chosen to receive on my order form may be discontinued by ENZACTA. In such situations, ENZACTA will notify me of the change and will continue to send me the remaining items specified on my order form, unless I request differently. Price and shipping fees will be automatically reduced in accordance to the cost of the discontinued product(s).

- Change of Price:** I understand that the price of the specific products which I have chosen on my order form may change due to reformulations, improvements, or other reasons. When such price changes occur, ENZACTA will notify me of any price increases and, unless I direct them to do otherwise, will continue to send me the products specified in my order form at the increased price.

- Termination/Suspension of Autoship:** I understand and agree that this agreement will be suspended without notice if I violate any of the terms and conditions of the agreement. I also understand and agree that this Autoship Program Agreement may be immediately terminated without notice if credit card(s) to which product purchases have been charged become expired, canceled, or otherwise terminated. If this Autoship Program Agreement is terminated for any reason, I may submit a new order form for review and, if accepted, may reestablish a standing monthly order relationship with ENZACTA.

- Change of Order:** I understand that I may change my Autoship order at anytime during the month as long it falls five (5) business days prior to my scheduled Autoship date. I also realize that my scheduled Autoship date cannot be scheduled after the 28th of each month. All changes must be submitted in writing to ENZACTA.

- Cancellation of Autoship:** I understand I must provide ENZACTA written notice to cancel Autoship five (5) business days prior to shipment. If I do not notify ENZACTA, the Autoship order will continue to be shipped and my card debited each month.

- Policies and Procedures:** I understand that the terms and conditions contained in this Autoship Agreement do not supersede or modify in any way the terms and conditions of my Agreement with ENZACTA or its Policies and Procedures.

- Return/Refund of Products:** I will immediately inspect each shipment to determine whether the order is complete and in good condition. If an order is not delivered in complete or proper condition I will contact the Orders Department at ENZACTA. I understand that all products ordered under the Autoship Program for personal consumption may be returned according to ENZACTA's regular product return policy. I also understand that any products I purchase through the Autoship Program are eligible for refunds in accordance with the Policies and Procedures.

- Start-Up Autoship Promotion:** I understand the Start-Up Autoship Promotion is only available to new IBOs and Personal Customers who submit an Autoship form within ten days after joining ENZACTA. A new IBO or Personal Customer can submit their Autoship order within the 10 day window and may select the autoship to start in the current month or the month after starting their business to be eligible for the Start-Up Autoship Promotion. *If I choose the Start-Up Autoship Promotion -* (a) I understand that if I discontinue, cancel, do not pay my autoship on time, or terminate my business, I will not be allowed to reinstate the Start-Up Autoship Promotion. (b) I understand I may add additional items to my monthly autoship order. These additional items may be changed monthly but the Start-Up Autoship Promotion must remain on the monthly autoship in order to maintain promotion eligibility. (c) I understand that this promotion is subject to price and/or BV changes. In the case of a price and/or BV change I will be notified in advance of my autoship date.

Buyer's Right to Cancel - You may cancel this contract from the day you enter into the contract until 10 days after you receive a copy of the contract. You do not need a reason to cancel.

If you do not receive the goods or services within 30 days of the date stated in the contract, you may cancel this contract within one year of the contract date. You lose that right if you accept delivery after the 30 days. There are other grounds for extended cancellation. For more information, you may contact your local consumer affairs office. If you cancel this contract, the seller has 15 days to refund your money and any trade-in, or the cash value of the trade-in. You must then return the goods. To cancel, you must give notice of cancellation at the address in this contract. You must give notice of cancellation by a method that will allow you to prove that you gave notice, including registered mail, fax, or by personal delivery.
